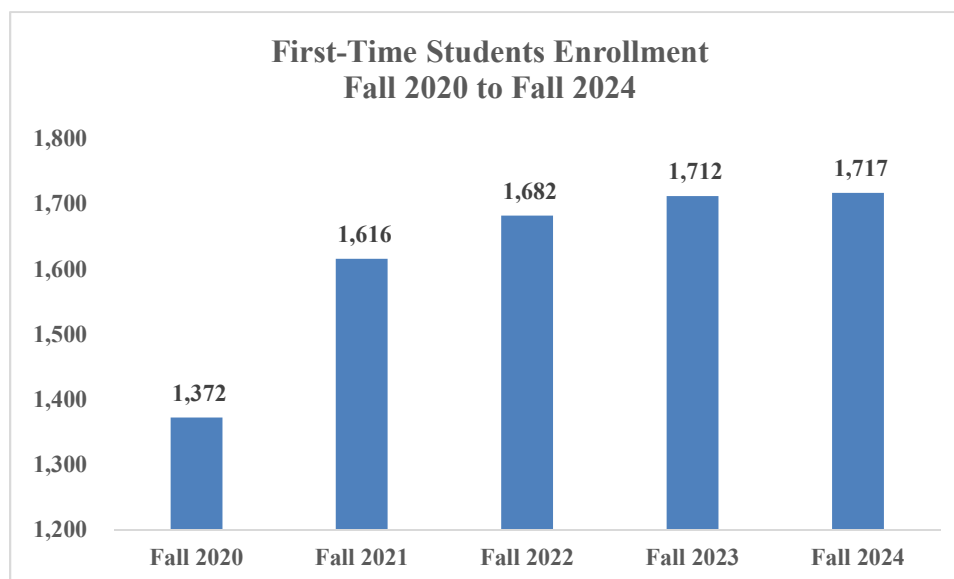

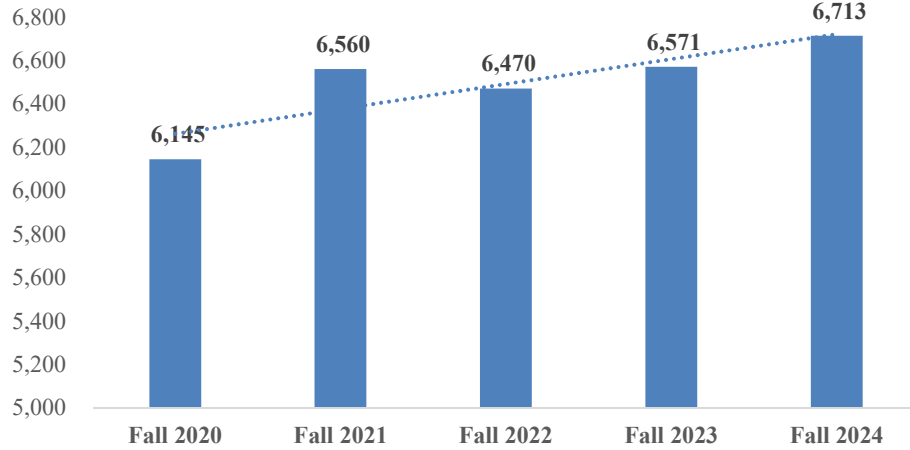

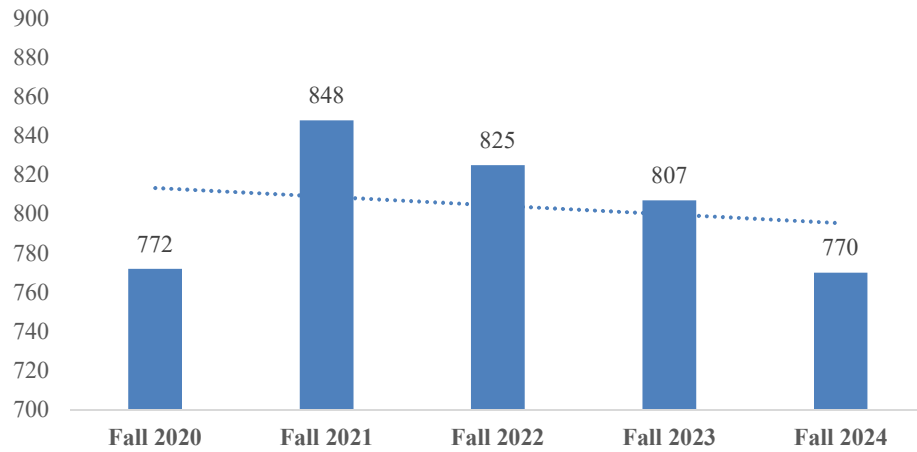

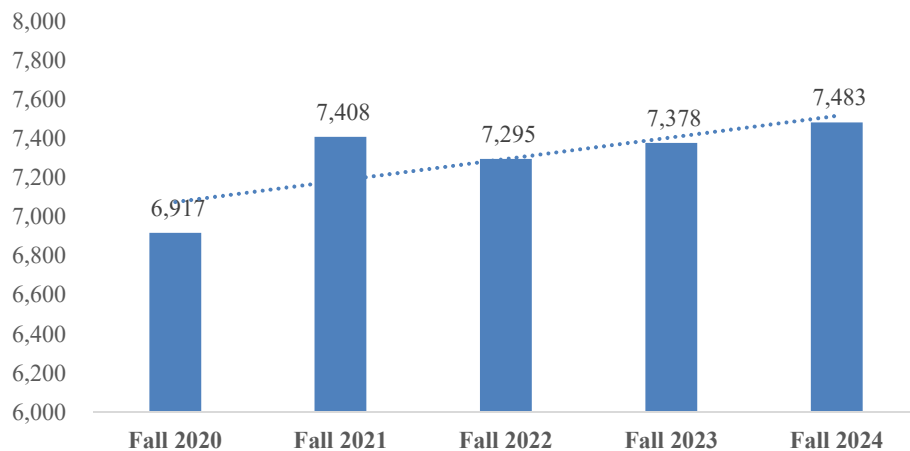
Undergraduate Students Enrollment Fall 2020 to Fall 2024

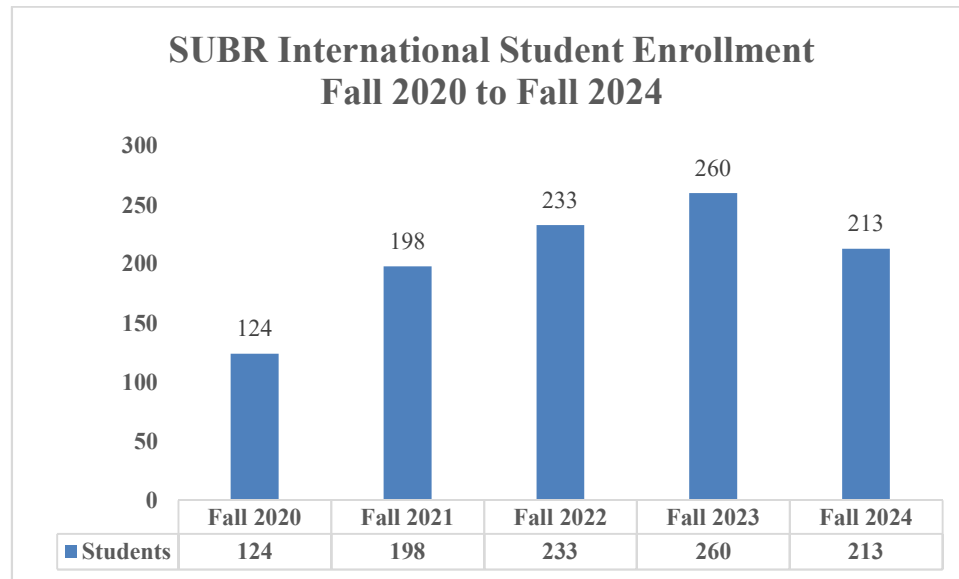

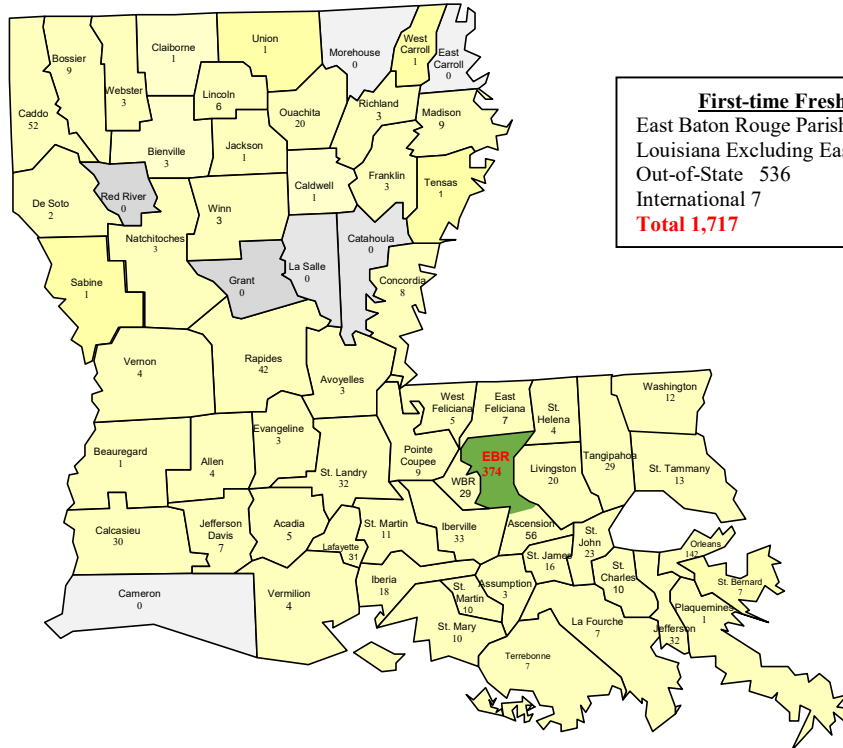
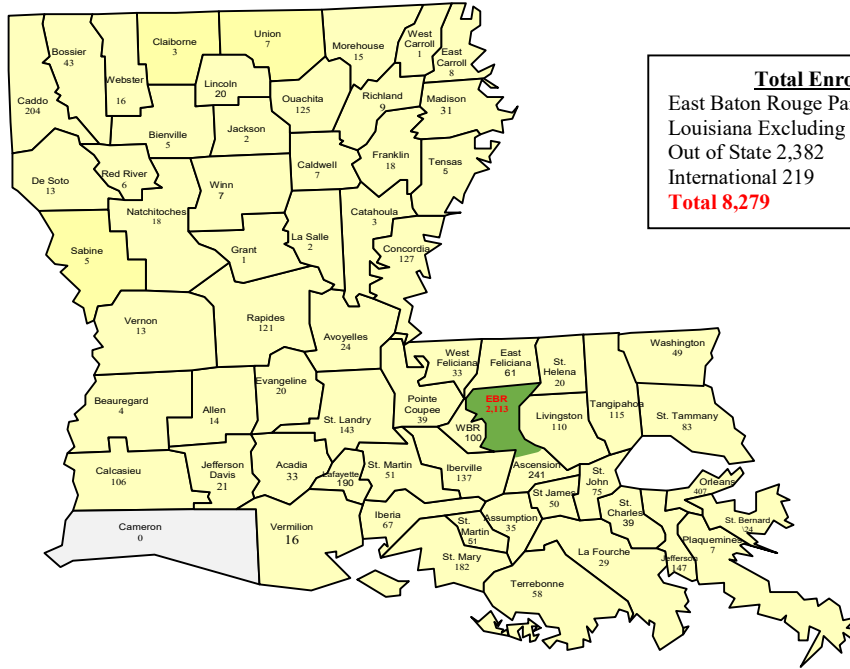

Student Enrollment by Parish, Fall 2024

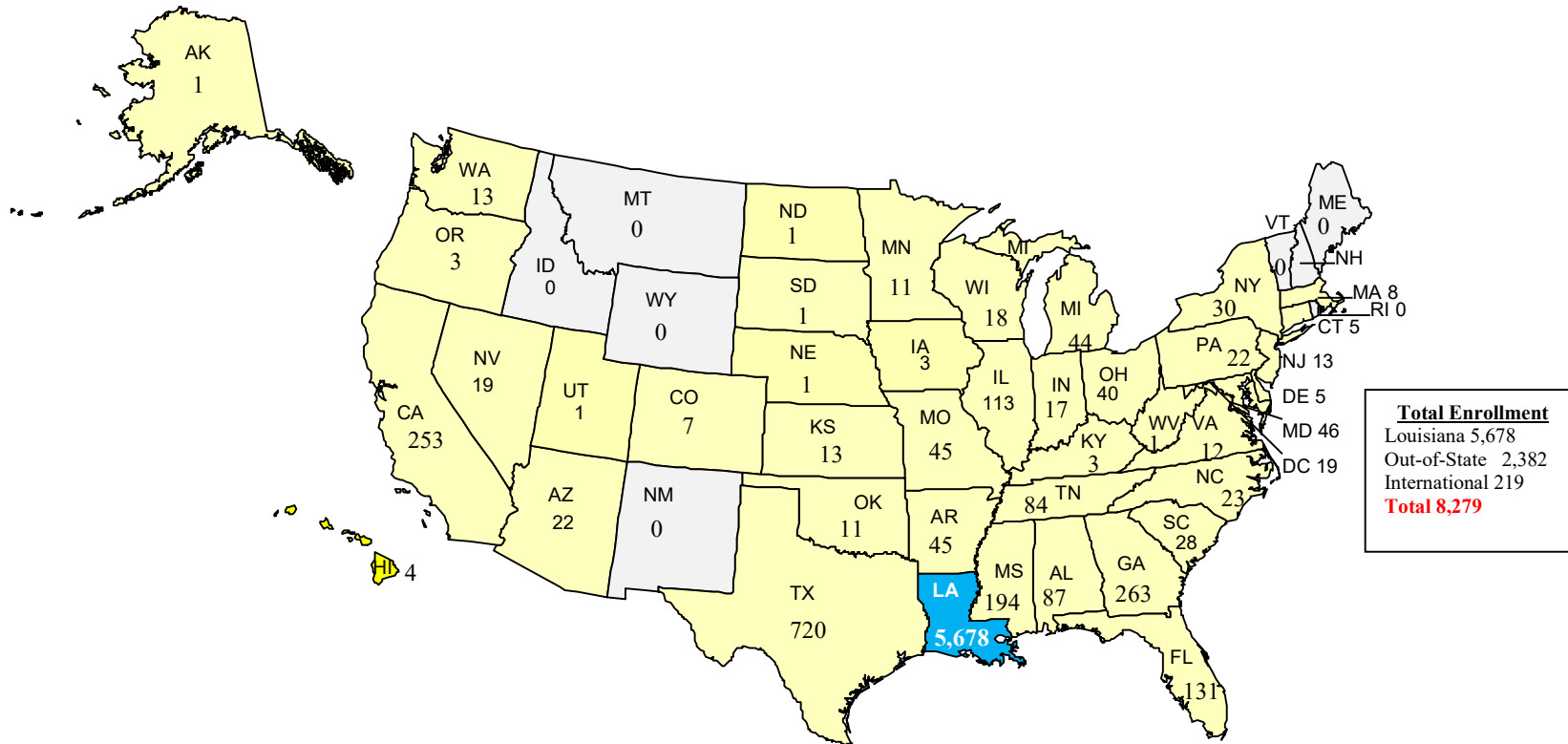
